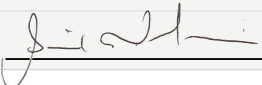

Sliding Fee Discount Schedule Overview

| Tier     | Income Level | Patient Pays     | Discount      |
|----------|--------------|------------------|---------------|
| TIER 1   | 0-100% FPG   | \$20 nominal fee | 100% discount |
| TIER 2   | 101-150% FPG | \$30 per visit   | 80% discount  |
| TIER 3a  | 151-175% FPG | \$60 per visit   | 60% discount  |
| TIER 3b  | 176-200% FPG | \$90 per visit   | 40% discount  |
| FULL FEE | >200% FPG    | \$150 per visit  | Standard rate |

Discounts may be available for eligible patients receiving covered services at Narkar Health Foundation.

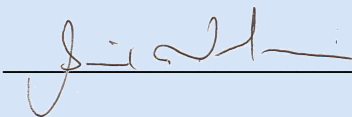
